ADOPTION OF MAY MEETING MINUTES & ELECTION OF OFFICERS

MOTION: To adopt the minutes of the May and Annual meetings of the Trustees.

• Move to accept by Melody, seconded by Humphrey. Passed unanimously.

Jim presented the slate of officers for the current fiscal year for adoption by the Board present. The slate is Okun, Chair; Foti, Treasurer; Tyler, Secretary; Talcott, NH/VT Vice Chair; Austin, MA Vice Chair; Moore, CT Vice Chair

MOTION: To approve the slate of officers for the current FY 15 - 16.

• Move to accept by Brewster, seconded by Melody. Passed unanimously.

B. MARKETING & PUBLICITY

Meghan, from 6 Point Creative, presented their progress on ideas for branding, including a draft press release, and 2 styles of brochures, featuring a proposed new name and logo. She proposed next steps. Trustees gave feedback and asked questions. Gratitude was expressed to Meghan and 6 Point Creative for all their work.

<u>MOTION:</u> Endorse staff and any interested Trustees to continue working with 6Point Creative to test market "Great River Trust" and "Connecticut River Trust" as potential new names, test related materials, with key groups, and present findings at the November Board meeting.

• Move to accept by Humphrey, seconded by Liz. Passed unanimously.

C. FINANCE & DEVELOPMENT REPORT

CONNECTICUT RIVER WATERSHED COUNCIL, INC.

Andy and Phil shared several YTD finance reports (FY15 Budget v Actual, Statement of Financial Position as of Aug 31, 2015, FY 16 Budget v Actual July through Aug 2015, P&L Comparison July through Aug 2015, and Grant Status Report May to Sept 2015). Phil noted that we have built a robust system for tracking grants.

Dana presented the Development Report.

MOTION: To adopt the YTD finance & development reports as presented.

• Move to accept by Liz, seconded by Melody. Passed unanimously.

In order to continue repaying the secured internal loan made against the Shaub Endowment, Melody recommended that a second payment of \$50,000 be made via a transfer from the Unrestricted Endowment. This makes \$100,000 that has been transferred from the Unrestricted Endowment in the last two years. The Board discussed and reviewed the progress made to repay this loan.

<u>MOTION:</u> To transfer \$50,000 from the Unrestricted Endowment to the Shaub Endowment Fund as further repayment of the secured internal loan.

• Move to accept by Melody, seconded by Humphrey. Passed unanimously

Melody reported on the status of the Finance Committee's work to find a new investment advisor. The Committee has held two meetings and reviewed a variety of proposals. Their strategy is to find an advisory service that can deliver low-cost investment vehicles such as exchange traded funds or individual laddered bonds that require little or no management but also provide on a quarterly basis an investment advisor to help with any adjustments or refinements. This strategy will give us the best of both worlds – low-cost investments that have the ability to outperform our current investment strategy but with a disinterested person to guide the Committee's thinking as it annually updates investment policies.

PROCESS: NEXT STEPS: Treasurer and Finance Committee will evaluate potential investments advisors, and make a recommendation. If they have a recommendation for the Trustees ready prior to the Nov 6 meeting, the Trustees agreed to a special meeting via conference call and polling to make the decision, so action on it may be taken in a timely way. If the decision is made in this way, it will be officially minuted, and the decision will be ratified by the Trustees at the Nov. meeting.

PROGRAM UPDATES

Andy presented updates on the following programs:

River steward updates

Andy shared recent successes achieved or in process by all river stewards.

Source to Sea - Ambassador visits

CONNECTICUT RIVER WATERSHED COUNCIL. INC.

Andy shared updates on organizing for this event. Dana invited Trustees to sign up for serving as ambassadors at sites near them.

Chang Farms enforcement action

Andy reported on the status of negotiations with the Chang Farm facility to resolve the wastewater permit violations.

Land Conservation Program

Andy noted that several projects are moving along and that with fingers crossed we may have transferred the Levenger property (Leverett, MA) and completed the two easement consolidations with the UVLT by the next meeting. In addition we have submitted two CT properties (deForest and Hibbs) to CT DEEP for their consideration of purchasing these two parcels as adjacent additions to state forest land. The Spaulding Pond dam project is also progressing with the expectation of a revised dam reconstruction design that is smaller and less expensive being completed in September. Bidding would happen this winter and construction next summer/fall.

Jim adjourned the meeting at 3:30 pm.

Site visits / stewardship inspections

Levenger property cleaned up in August & September! Braasch and Carmichael easement visits in Lyme, NH in September.

Completed transfers / sales

None since last meeting.

<u>Current issues / updates / concerns / violations</u>

<u>Several NH easements</u>: The Society for Protection of New Hampshire Forests is a backup easement holder for several easements that have in northern NH. Several large conservation organizations have been asked by the NH AG to let them know if they know of easements that are not being monitored.

<u>Hibbs & deforest properties – Hebron & Haddam, CT:</u> These two parcels are now back under consideration for purchase by the State as they both abut state forest parcels. I am in communication again with the land management program at DEEP and they will get us an answer later this fall. I am cautiously optimistic that we may get these in the purchase queue in 2015 or 2016. NO FURTHER UPDATE SINCE SEPTEMBER

<u>Levenger property – Shutesbury</u>. We are in the process of preparing a quit claim deed, hopefully by Rob Costello. Mike Mauri will take title to the property for \$1 once we get the deed prepared. Hopefully this calendar year.

Spaulding Pond, Norfolk, CT: We are waiting for the final design which was scheduled for late

September. It is overdue. We still plan to bid the dam reconstruction this winter for construction next year. Discussions with the family about their cost share have not proceeded as we are waiting on the design. We have mowed the fields again this year with some additional field edge clearing. The Housatonic Valley Association approached us about work they are doing to transfer all easements held by the CT Conservation Association (which holds the easement on our fee interest here) to the Aton Forest. HVA has received grant funding to help with this and they will be surveying the property and creating a baseline document. This is a very positive development as CCA is not currently an active organization and HVA is managing and funding the entire process.

<u>Blodgett easement consolidation, Lyme, NH:</u> I have spoken with Jeannie McIntyre and this is continuing to rattle along, with a perhaps new legal approach being tried. Waiting for UVLT to decide which course they want to pursue.

<u>Holyoke land transfers, Holyoke, MA:</u> Sam Lovejoy, the state's land agent has retired effective September 1 so the various transfers underway are now going into cold storage until his replacement is found. This is stuck again until the state rehires Sam's position.

<u>Speer fee parcel, Corinth, VT:</u> No action on this since last meeting. Transfer to UVLT is not likely given the costs. A new game plan needs to be developed. I think a bargain sale to abutter is best option to get it off our lists. We pay taxes each year on this as it is not eligible under VT law for abatement.

<u>Hemenway easement transfer, Strafford, VT:</u> Still no action. We are waiting to hear from VRC about their acceptance of a draft easement prepared by our summer law intern. I need to reinitiate conversations with VRC. This needs funding to support the stewardship costs of the easement, which the landowner is not willing to provide.
